REVIEW OF THE MARCH 31, 2025 YEAR TO DATE EIC FINANCIAL RESULTS

Susan Morth and Alain Pierroz reviewed the results for the quarter ending March 31, 2025.

Alain noted that the first quarter results include approximately \$60k in on-going administration income relating to previously closed projects, projecting that this amount will total approximately \$200k for the full year. Alain further noted that this on-going administration income will continue to sustain EIC.

Susan Morth stated that EIC is anticipating closing some transactions this summer.



STATUS OF PROPOSED C-PACE LEGISLATION IN THE NEW YORK STATE LEGISLATURE

Susan Morth noted that there was an attempt by New York City to amend the C-PACE statute in the N.Y. State Legislature. However, the legislation did not pass both the Senate and Assembly. Failure to pass this legislation continues to inhibit the use of the C-PACE program in New York City and New York State.
